We thank you for your interest in our company. Your data privacy is important for us and we would like to inform you about the use of your personal data. The company D+1 is concerned about the importance of the use given to personal data, and we act according to the GDPR.

By signing this declaration, you declare to have read these terms, and you expressly consent us the use and access to your personal data hereafter described. This consent is given to D+1 as well as, all the companies part of the Holding (that is Yolé and Tapas Club) according to the program purpose.

This Terms of Use do not alter in any way the terms or conditions of any other agreement you may have with any of the D+1 operated brand (Yolé and Tapas Club) for products, services or otherwise. D+1 reserves the right to change, modify and/or terminate the D+1 holding Rewards program and/or these Terms of Use or any policy, FAQ, or guideline pertaining to D+1 Holding Rewards at any time and in its sole discretion.

Your participation in D+1 Holding Rewards confirms your acceptance of these Terms of Use and any such changes or modifications; therefore, you should review these Terms of Use and applicable policies from time to time to understand the terms and conditions that apply to D+1 Holding Rewards. If you do not agree to these Terms of Use, you must stop participating in D+1 Holding Rewards.

Program overview and personal data required

D+1 Holding Rewards is one way in which D+1 Holding endeavors to reward and thank loyal customers for patronizing at D+1 Holding brands in Singapore. To enroll in D+1 Holding Rewards and receive program benefits, you will first need to sign up through our online form in our brand address to our different rewards programs "The Club" <http://www.tapasclub.com/theclub/> or "Yolé Rewards" <http://www.yoleicecream.com/yolerewards/>. The registration in our D+1 Holding Rewards program may require that you provide certain personal information using our online registration form, including: email address, birthday, name, gender and mobile number. Your mobile number will be your ID in the rewards program and you will only have one account personal linked to you.

D+1 Holding Rewards benefits are determined based on the amount of "spending" you make and the number of "points" that you earn through your spending in our outlets. For the program "Yolé Rewards" for every 1 Singapore dollar that you spend in Singapore you will

receive one (1) "Point" (If you spend \$1.10, you will earn 1.10 points), except during limited time promotions when D+1 may offer "Bonus Points" on featured products and/or services. For the program "The Club" for every 1 Singapore dollar that you spend in Singapore you will receive one (1) "Point" (If you spend \$1.10, you will earn 1.10 points), except during limited time promotions when D+1 may offer "Bonus Points" on featured products and/or services.

Points are for promotional purposes only and have no cash value. You will need to identify yourself as a Yolé Rewards member or The Club member to earn points for your spending. **Please note that spending will only be calculated and points accumulated after your join our rewards program**

Your complimentary birthday reward will be automatically loaded into your account on the first day of your birthday month, or on the day you registered for a loyalty program during your birthday month (whichever is earlier). The complimentary birthday reward will expire automatically 31 days later.

Additional personalized offers, promotions and event invitations may be distributed by email or SMS, so you must opt-in to receive such promotional and marketing offers from D+1 Holding. You must provide a valid email or valid mobile number in order to receive the additional offers, promotions and event invitations.

You can view and track your available rewards on our outlets identifying yourself as "Yolé Rewards" or "The Club" member and providing your phone number and identification. To redeem a reward under D+1 Holding Rewards, you must present an identification and refer to your phone number.

Unless specifically provided to the contrary, only one reward may be redeemed with each transaction regardless of the membership level. This means that you cannot use more than one reward together in the same transaction.

There are no membership fees associated with D+1 Holding Rewards. The points and rewards accumulated under the program have no cash value. No points or rewards may be exchanged for cash.

Personal data processing

The use of your personal data by our company is limited to the purpose of the program unless you expressly consent another application. Your points and benefits, registered D+1 Holding Rewards, and your account under D+1 Holding Rewards are personal to you, and except as expressly permitted under these Terms of Use or the rules of a promotional program, may not be sold, transferred or assigned to, or shared with family, friends or others.

Data security

The company has implemented technical and organizational measures in order to ensure your personal data security, in case of lost or unauthorized handling or access. These measures are periodically revised according to the technical standards. In case of data protection breach, we will notify you as soon as possible.

Nonetheless, you are the sole responsible of your email and password security. D+1 will not be responsible of any damage caused as consequence of any email or password loss or theft, beyond the data security abovementioned.

Affected rights

Right to information: you can ask us for confirmation about the treatment given to your personal data.

Right of rectification: in case of incomplete or inaccurate personal data, you can ask for its correction.

Right of access: you can access at any moment to your personal account and verify the personal data that are being handled by us.

Right to limit data processing: you can ask for a limitation in your personal data processing in case you consider some of the personal data are no longer necessary for the program purpose.

Right of withdrawal: we ensure you that we will keep your personal data as long as they are necessary for the purpose abovementioned. Nevertheless, you have the right to ask us for its deletion at any moment and we grant you that your personal data will be automatically deleted unless there is just cause. Additionally, D+1 HOLDING reserves the right to terminate your account and/or your participation in D D+1 Holding Rewards if D+1 HOLDING determines in its sole discretion that you have violated these Terms of Use, or that the use of your account is unauthorized, fraudulent or otherwise unlawful.
